Fulton County has an average employee count of 247. For the Claims/Premiums Data (Loss Ratio) Fulton County's 12 month vision loss is 108%, 12 month dental loss is 88.9%, medical and prescription loss is 133.9%. The medical and prescription drug claims have 10 large claims. The top five high claim health conditions are musculoskeletal, neoplasms, health status, injury and poisoning and digestive systems. Fulton County has seen a decrease in the claim dollars for inpatient but saw an increase in outpatient with a slight decrease in professional visits. Fulton County has a total of 120 ER visits with 47 falling into a non-emergent diagnosis. The top five inpatient facility providers in order are Cleveland Clinic, Toledo Hospital, Mercy St. Vincent, St. Luke's Hospital, and Defiance Regional Medical Center. Fulton County Health Center is #7 for the inpatient but #1 for number of members for outpatient.

WHEREAS, a collective bargaining agreement has been successfully negotiated with the Fulton County Engineer and Ohio Council 8, American Federation of State, County and Municipal Employees, AFL-CIO and its Local 2782, American Federation of State, County and Municipal Employees AFL-CIO, for the establishment of rates of pay, hours of work, benefits and other terms and conditions of employment.

THEREFORE, BE IT RESOLVED, after deliberation, the Fulton County Board of Commissioners hereby ratify collective bargaining agreement 2020-47 by and between the Ohio Council 8, American Federation of State, County and Municipal Employees, AFL-CIO and it's Local 2782, American Federation of State, County and Municipal Employees, ALF-CIO, and the Fulton County Engineer; and

BE IT FURTHER RESOLVED, that this agreement shall be effective March 1, 2023 and shall remain in full force and effect through midnight on February 28, 2026; and

BE IT FURTHER RESOLVED that it is found and determined that all formal actions of this Board of County Commissioners, County of Fulton, State of Ohio concerning the adoption of this resolution were adopted in an open meeting of this Board of County Commissioners, and that all deliberations of this Board of County Commissioners and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
