WHEREAS, Ohio House Bill 59 (Budget Bill) amended Sections 955.01, 955.05, 955.06, 955.07, 955.08, and 955.09 of the Revised Code regarding establishment of mandated options for dog registration for a 1 year dog license or 3 year dog license or permanent dog license effective December 1, 2013; and,

WHEREAS, the County Commissioners have reviewed the total expense incurred in the Administration of the dog law and the amount of money allowed for animals, fowl, or poultry injured and destroyed, and the amount received as dog and kennel registration fees, and other receipts.

THEREFORE BE IT RESOLVED, that the Dog License, Boarding, Redemption, and Adoption fees for the year 2020 shall be continued as follows:

- Single Year License \$20.00 with a \$20.00 late fee penalty ORC 955.05
- Three Year License \$20.00 times 3 = \$60.00 ORC 955.14, with a \$20.00 late fee penalty ORC 955.05
- Permanent License \$20.00 times 10 = \$200.00 ORC 955.14, with a \$20.00 late fee penalty ORC 955.05
- Kennel License \$100.00 with a \$100.00 late fee penalty ORC 955.05

- Boarding Fee \$10.00 per day, per dog
- Redemption Fee \$20.00 per dog
- Adoption Fee \$15.00 per dog
- Euthanasia Fee \$50.00 per dog
- Disposal Fee \$50.00 per dog
- Tranquilizing Fee \$50.00 per dart

OSU College of Veterinary Medicine .20 cents-1 Yr., .60 cents-3 Yr., \$2.00-Permanent per ORC 955.14

BE IT FURTHER RESOLVED, that the deadline for purchasing these dog licenses Without penalty shall be extended to coincide with the due date of the Fulton County First Half Real Estate Taxes; and

BE IT FURTHER RESOLVED, that the Drug Law Enforcement dogs, which are used by the Fulton County Law Enforcement Agencies, shall be given dog license tags but the fee shall be waived for these county dogs pursuant to ORC 955.012; and.

BE IT FURTHER RESOLVED that it is found and determined that all formal actions of this Board of County Commissioners, County of Fulton, State of Ohio concerning the adoption of this resolution were adopted in an open meeting of this Board of County Commissioners, and that all deliberations of this Board of County Commissioners and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
