Clark Emmons seconded the Resolution and the roll being called upon its adoption the vote resulted as follows: Emmons-yes; Holman-yes; Stubbins-yes. Motion Carried.

Herb will report to the Trustees if the lawn is not mowed for the upcoming summer and the issue will be dealt with at that time.
