April 24, 2017

The Trustees of German Township, Fulton County, Ohio met in regular session for the purpose of conducting business of the township.

Present: Bruce Lauber, Kenneth Leupp, Randy Ruffer, Keith Short

Guests: Jeff Aeschliman, David Pugh, Donna Dettling, Spencer Short

The meeting was called to order by Bruce at 7:00 pm.

The minutes from the April 10, 2017 meeting were presented. Kenneth made a motion to accept the minutes as presented. Randy seconded the motion. The motion passed with three yes votes and no negative votes.

Donna said Brett Kolb will be attending the Village Council meeting on May 1 and invited the trustees to that meeting. Donna will let the council know the trustees have been invited.

Spencer Short reported they farm at the corner of Co BC and Co Rd 25 and they have a drainage problem. An outlet was put in many years ago and more farmers have tied into it, which has put a burden on the outlet. He said they would like to have a better outlet installed so that the ground will drain better. The Trustees told Spencer they will look at the situation to determine what options would be available.

The bills were presented for review (attachment 04-04-17). Randy made a motion to accept the bills for payment as presented. Kenneth seconded the motion. The motion passed with three yes votes and no negative votes.

Jeff reported they have been working on road berms, worked on a deck gun on Fire truck #102, worked on Fire Truck #100, flushed the tile by Mike Stuckey, and rolled the lawn at Johnson Cemetery. Miller Brothers is going to grind out the ruts on Co Rd G.

A Letter of Transmittal was received to bury a cable for a bridge replacement under the right of way of Road 25, 0.2 miles North from Road D (attachment 05-04-17).

Kenneth received a quote from Nofzinger Electric to repair the light fixtures in Old Mill Run in the amount of \$3,700.00 and had previously received a quote from Creighton Electric in the amount of \$1,972.00 (attachment 06-04-17).

G.T. Contracting, Inc. will be asked to provide a quote to crack seal Co Rd B from Archbold Village limits to Co Rd 21 and Co Rd B from Co Rd 19 to Co Rd 20, Co Rd 20 from Co Rd B to Co Rd C and Co Rd F from Co Rd 19 to Co Rd 21 and from Co Rd F from State Route 66 to Co Rd 26 for a total of 1 ³/₄ miles (attachment 07-04-17). **At the May 8, 2017 meeting it was determined this list of roads were incorrect.**

Randy made a motion to adjourn at 8:26 pm. Kenneth seconded the motion. The motion passed with three yes votes and no negative votes.
