The Trustees of German Township, Fulton County, Ohio met in regular session for conducting business of the township.

Kenneth called the meeting to order at 7:00 pm.

Stephen presented the September zoning report (attachment 01-10-18).

Randy Ruffer attended to discuss the flooding he has experienced in his barn from the water damming up on the north side of the road. Kenneth received a drawing from Rod Creager from the Fulton County Engineer's office (attachment 02-10-18). We will ask Rod Creager to draw up the project so that we can get cost estimates.

Keith presented the minutes from the September 24, 2018 meeting. Andy made a motion to accept the minutes as presented. Joe seconded the motion. The motion passed with three yes votes and no negative votes.

Keith presented the September 2018 financial reports for review.

Keith presented the September 2018 bank statement for review.

Keith presented the bills for review (attachment 03-10-18). Andy made a motion to accept the bills for payment as presented. Joe seconded the motion. The motion passed with three yes votes and no negative votes.

We received a legal notice for a ditch improvement petition of Branch 7 of Grass Run (attachment 04-10-18). There will be a viewing at the site on October 25, 2018 at 10:00 am beginning at Co Rd 22, ½ mile north of State Route 2, in front of 5511 CR 22, Archbold. The first hearing will be on November 15, 2018 at 10:00 am in the Fulton County Commissioners Chambers.

Robert Apger presented a \$300.00 check for the burial of Carol Nafziger in Johnson Cemetery. He also stated he cleaned up some of the trees at the cemetery.

Andy asked if there has been any update on the Pettisville sewer project. Kenneth said he has not heard anything.

Kenneth said Gerken Paving would let him know on Thursday when they can show up to start working on our roads.

There was some discussion regarding health insurance. We received a 37.93% increase for our same health insurance plan for next year. Andy will contact Crystal Meyer who represents Northern Buckeye
