FISCAL OFFICER REPORT Fiscal Officer presented the following reports: Payment register, Receipt register, Fund Status, Cash Journal, Cash Summary by Fund, Bank Statement and Bank Reconciliation Report. The new rate for the electric Aggregation Plan is .04897 for 24 months. The Trustees will stay with the existing plan and go to the new rate. The Fulton County Ohio Township Association is asking that the Townships contact businesses and ask for donations for the Fish Fry. Clark is interested in having a realtor look at the property next to the Township to see what it would be worth if the building was removed.

Resolution 18-3-18-19 Clark Emmons made a motion to approve Then & Now PO 25-2019 in the amount of \$18.12 for Kinsman Propane. Seconded by James Stubbins. Motion Carried. By vote: Emmons-yes; Holman-yes; Stubbins-yes.

Resolution 19-3-18-19 Clark Emmons made a motion to approve Then & Now PO 26-2019 in the amount of \$1,119.24 for the Fulton County Engineer. Seconded by Paul Holman. Motion Carried. By vote: Emmons-yes; Holman-yes; Stubbins-yes.

ROADS Herb Harris reported that he picked up brush, painted, and did other items as needed in the Township. The Trustees are interested in having the Township's roads marked. Before that can be done, the Township has to hire someone to log the roads. Jim will check into available grants for this project.

Resolution 20-3-18-9 James Stubbins made a motion to have the Right-of-Way surveyed on County Road 14, North of 120 to County Road U. Seconded by Paul Holman. Motion carried. By vote: Emmons-yes; Holman-yes; Stubbins-yes.

ZONING Another person is still needed to serve on the Zoning Board of Appeals. The Trustees have a few people in mind and will ask if they are interested. The Trustees and Herb discussed the properties that were sent blight letters. Herb reported that only one property looks like progress has been made.
