**ROADS** Herb Harris reported graded the stone roads, picked up brush, worked in shop, and completed other items as needed.

**ZONING** Tammy Richardson, FCRPC forwarded correspondence between the FCRPC and Melvin Wyse regarding a mobile home being placed on his property. A letter from Devon Stutzman was also received regarding the Zoning Inspector's correspondence to him regarding a blight violation. The letter will be forwarded to the Fulton County Prosecuting Attorney. Herb Harris discussed with the Trustees the regulations that need to be addressed if a resident wants to allow a commercial bulk LP tank to be installed on his property. Zoning does not allow this, so the resident would need to file for the property to be changed to be commercially zoned. It is possible that this issue may need to even be voted on by the residents. Don Reynolds attended the meeting and completed a Zoning Application for an accessory building.
