**FISCAL OFFICER REPORT** Fiscal Officer presented the following reports: Payment register, Receipt register, Fund Status, Cash Journal, Cash Summary by Fund, Bank Statement, Bank Reconciliation Report. The Fulton County OTA has requested membership forms and dues be turned in by June 10, 2019.

**ROADS** The Fulton County Engineer’s office sent an updated estimate for the Township’s road projects this year. The estimate increased from \$106,260.00 to \$111,546.00. The Trustee’s discussed the pricing received from Frank OnWeller for salt at \$113.43 per ton. The Trustees will keep their request at 75 ton. The Trustees discussed if anything needs done on their part for Breakfast on the Farm. Herb Harris reported that he is mowing as much as he can around the rain. He also moved dirt out of Stutzman’s field.

**ZONING** James & Sabrina Reese attended the meeting to inquire about a shared well on their property. They are planning on putting a trailer on a parcel next to their main property. They would like to share the well. According to the subdivision rule of Fulton County, that is not allowable.

**Resolution 29-6-3-19** James Stubbins made a motion to pay Ohio Township Association Associate dues for the Chesterfield Township Zoning Board and Zoning Board of Appeals. Seconded by Clark Emmons. By vote: Emmons-yes, Holman-yes, Stubbins-yes.

**Resolution 30-6-3-19** WHEREAS: HB 852 provides for the payment from the township's General Fund for membership dues to the Ohio Township Association, as well as subscription to the Ohio Township News, Clark Emmons made a motion that the township pay these costs of \$50.00 per trustee/clerk from the General Fund. Motion seconded by James Stubbins. Motion carried. By vote: Paul Holman-yes; Clark Emmons-yes; Jim Stubbins-yes.
