The Trustees of German Township, Fulton County, Ohio met in regular session for conducting business of the township.

Andy called the meeting to order at 6:00 pm.

Keith presented the minutes from the July 22, 2019 meeting. Andy made a motion to accept the minutes as presented. Kenneth seconded the motion. The motion passed with two yes votes and no negative votes.

Keith presented the July 2019 bank statement for review.

Keith presented the bills for review (attachment 01-08-19). Kenneth made a motion to accept the bills for payment as presented. Andy seconded the motion. The motion passed with two yes votes and no negative votes.

Keith presented the July 2019 financial reports for review.

Joe Garcia from G.T. Contracting, Inc. wanted to inform us that he and his brother Albert are continuing with the business their father started. He wanted to let us know they received a new crack-sealing machine.

Robert Apger said there was a burial in Goll Woods. The headstones at all cemeteries have been power washed.

Josh said they cleaned up a tree that came down, did some dura patching work, prepared the salt building for the painting of the building, hauled some dirt on to the township lot, worked on a starter for a fire truck repaired some tiles on Road E, Road 25, Road G and Road 20-2 and started mowing ditches. They had to replace a stop sign damaged with spray paint.

Eric Miller provided an estimate from Dave Dammon to replace an old clay drain tile with 8" plastic located at 19419 Co Rd B for \$2,500.00 (attachment 05-08-19). Josh will contact the engineer's office to determine who the landowners are and how many acres they own that drains into the tile to calculate each owners share.

11-19 RESOLUTION FOR BIDS FOR ROAD B DRAINAGE PROJECT

Bids were received and opened at the Fulton County Engineer's Office on July 24, 2019 for the Road B Drainage Project. Blausey Truck Service and Excavating, LLC bid \$165,420.05, The Weber Company bid \$173,299.44 and Fenson Contracting, LLC bid \$205,588.00 (attachment 06-08-19). With an Engineer's estimate of \$187,000, we have determined that the bid of \$165,420.05 from Blausey Truck Service and Excavating, LLC is correct and hereby award the bid for the German Township Road B Drainage Project to Blausey Truck Service and Excavating, LLC of Elmore, Ohio in the amount of \$165,420.05. Kenneth made a motion to accept the bid from Blausey Truck Service and Excavating, LLC for \$165,420.05.
