Board of Trustees  
June 24, 2019

The Trustees of German Township, Fulton County, Ohio met in regular session for conducting business of the township.

Present: Andy Brodbeck, Kenneth Leupp, Joe Short, Keith Short

Guests: Josh King, Jeff Aeschliman, Brad Short, Eric Miller, Robert Apper

Joe called the meeting to order at 7:30 am.

Eric Miller has a tile issue on Co Rd B between Co Rd 19 and Co Rd 20 (attachment 06-06-19). He has a tile landowners put in and then the township tied into it. He has repaired numerous tile washouts. According to the Fulton County Engineers Office, surface drainage into the tile shows Dean Genter has approximately six acres, Rick Roth three, German Township one and Eric Miller has one. Joe suggested Eric has the tile replaced and German Township and the other landowners would pay according to the acreage of surface water draining into the tile. The Engineer's Office suggested having an estimated cost of the replacement and sharing it with the landowners. Eric will get an estimate and discuss it with the landowners.

Josh reported a clay tile by the Dean Genter property on Co Rd B that is full of mud and the water is slow to drain. The length of the tile is approximately 530 feet. Josh suggested a 6" tile would be sufficient to drain the water away. It would be good to work with whoever is going to repair the tile for Eric Miller to do this tile at the same time.

Keith presented the minutes from the June 10, 2019 meeting. Andy made a motion to accept the minutes as presented. Kenneth seconded the motion. The motion passed with three yes votes and no negative votes.

Keith presented the bills for review (attachment 07-06-19). Andy made a motion to accept the bills for payment as presented. Kenneth seconded the motion. The motion passed with three yes votes and no negative votes.

Brad Short, Archbold Village Council representative, said there would be another notice sent to Village residents concerning the water not meeting the state requirements. They are working to correct the situation. There are things within the water and wastewater plants that will need updating in the future.

Robert Apper said Andy Dominique would attend the next meeting to explain the estimate he had prepared.

Josh reported they have been mowing ditches as weather has allowed, cut back some brush, trimmed some trees, cleaned up stump grindings on Co. Rd. B and has worked on the dirt at Dan Lange property.

A permit was received from Centurylink for a buried cable for culver replacement under the right-of-way of Road 24, 0.14 miles North from Road G (attachment 08-06-19). The permit number is GERROW2019-001.

A permit was received from Centurylink for a buried cable for culver replacement under the right-of-way of Road FG, 0.38 miles West from Road 26 (attachment 09-06-19). The permit number is GERROW2019-002.

**09-19 RESOLUTION FOR FUND TRANSFER**

BE IT RESOLVED by the Board of Trustees of German Township, Fulton County Ohio that \$10,000.00 be transferred from the General Fund (1000) to the Cemetery Fund (2041) (attachment 11-06-19) and to increase the Cemetery Appropriation Code 2041-410-323-0000 Repairs and Maintenance by \$10,000.00.

Hayley will prepare the bid documents to place in the Archbold Buckeye.
