The Trustees of German Township, Fulton County, Ohio met in regular session for conducting business of the township.

Present: Andy Brodbeck, Kenneth Leupp, Joe Short, Keith Roth

Guests: Josh King, Jeff Aeschliman, Bob Apgar, Jason Pursel, Dave Davis, David Pugh

Andy called the meeting to order at 7:30 am.

Keith presented the minutes from the August 10, 2020 meeting. Kenneth made a motion to accept the minutes as presented. Joe seconded the motion. The motion passed with three yes votes and no negative votes.

Bob Apgar reported that pedestrian signs were stolen at Goll woods. They cut off the wooden posts and took the signs. Because this has happened in the past it was agreed the new signs be put up with metal posts.

Chief Davis gave the fire department report. He brought the new thermal imaging camera that was just purchased by fire department. He passed it around and explained it is a good safety tool. Chief Davis reported on possible items to use for Covid grant money. Items included isolation gowns and respirator masks and replacement cartridges totaling \$4,651. Trustees agreed to order the items for the Covid grant money. Chief Davis also reported the fire department is canceling the feather party this year.

Keith presented the bills for review (attachment 02-08-20). Kenneth made a motion to accept the bills for payment as presented. Joe seconded the motion. The motion passed with three yes votes and no negative votes.

Josh reported on maintenance. They have been doing some fire department work. They worked on the tile on Road BC, replaced a section and the county jet truck flushed that section out. They also used the county jet truck to flush the tile on Road 26-3. With the storm last week there was some flooding and tree issues that were taken care of. Josh had conversation with Stanley Borton who lives on Rd FG about some trees he would like taken down. Josh spoke with Hayley and there is no right away established north of Road FG. Josh mentioned that if there was a 60 feet right away the two trees would be in the right away. It was decided we will obtain right away and then remove the trees. Josh reported on Road DE on the west end, a tile was broke and a catch basin needs replaced. The tile goes under road, need to dig that up and check it out. Josh mentioned the backhoe blew a fuel line on Route 2, Archbold truck service made something work to get them off the road.

Joe discussed uses for the Covid money. UV light, tables and chairs, air purification, gloves and masks, cleaning supplies, service master cleaning the building. We are going ahead with these items as they need to be paid for by October 15th.
