The Trustees of German Township, Fulton County, Ohio met in regular session for conducting business of the township.

Present: Andy Brodbeck, Kenneth Leupp, Joe Short, Keith Roth

Andy called the meeting to order at 7:30 am.

Keith presented the minutes from the September 14, 2020 meeting. Kenneth made a motion to accept the minutes as presented. Joe seconded the motion. The motion passed with three yes votes and no negative votes.

Bob Apgar presented burials for this year vs last year. Burials are up 200% over last year.

Keith presented the bills for review (attachment 01-09-20). Joe made a motion to accept the bills for payment as presented. Kenneth seconded the motion. The motion passed with three yes votes and no negative votes.

Josh reported on maintenance. They continue to do durapatching in several locations. They did some work for fire department, unit 102 had value stuck they fixed. They did some cleaning while the cleaning crew was here. Steve Fryman called about a street light out in Burlington, Josh called Toledo Edison and put a work order in. Steve then asked about possibly of adding another street light on Washington street in between the interesections. The trustees will go out there and take a look to see if another light is needed. We are going to remove stop signs on 24 at road G, they are going to put up new traffic pattern signs. They obtained a price for a possible new trailer, which was \$2,700 but no action was taken. Discussed winter salt quote from Morton, price was cheaper than last year. It was decided to order the same as last year which was 200 ton of salt.

Chief Davis talked about turnout gear, they have 36 members but only 35 would use turnout gear. Would not need helmets and boots because those are easily disinfected. Chief Davis will contact sales rep about turnout gear and the possibility of getting them here by December 30.

There was some more discussion on Covid money. Still waiting on additional quotes for possible ATV, a decision will be made at the next meeting.
