The Trustees of German Township, Fulton County, Ohio met in regular session for the purpose of conducting business of the township.

Present: Bruce Lauber, Kenneth Leupp, Randy Ruffer, Keith Short

Guests: Josh King, Linda Lauber, Pete Grieser, Vickie Ernst, Kevin Morton, Ed Partin

The meeting was called to order by Kenneth at 7:19 pm.

Linda Lauber presented the July zoning report (attachment 01-08-12).

Pete Grieser inquired about the alley behind his property in Elmira. There is a tree stump infringing on the alley and people drive on his property to avoid the stump. The county engineer's office will be contacted to survey the property so a decision can be made about the tree stump.

Vickie Ernst asked when the trustees wanted them to finish fog sealing Co Rd 24. The trustees suggested they do it on Saturday and have the road closed.

The minutes from the July 23, 2012 meeting were presented. Bruce made a motion to accept the minutes as presented. Randy seconded the motion. The motion passed with three yes votes and no negative votes.

Bruce made a motion to accept the Board of Zoning Appeals decision to allow Brian and Christine King to erect an accessory building in the front yard of their property at 3605 Co Rd 21, Archbold, OH 43502. Randy seconded the motion. The motion passed with three yes votes and no negative votes.

The July bank statement was presented for review.

Blanket Certificates 38-2012 and 39-2012 were presented for signatures. Then and Now Purchase Orders 3-2012, 4-2012 and 5-2012 were also presented for signatures.

The bills were presented for review (attachment 02-08-12). Randy made a motion to accept the bills for payment as presented. Bruce seconded the motion. The motion passed with three yes votes and no negative votes.

Josh said they have pulled back the berm on some roads, built a hose cart for the fire department and received a drive permit from Steve Frey.

Kevin Morton and Ed Partin, representing Andres O'Neil & Lowe Agency, were present to discuss the estimate received from OTARMA for the building damage. They recommended the trustees obtain a couple of estimates from contractors to present to OTARMA. Randy will also talk with Lee Short to get clarification on a few questions.

A signed haul permit route was received for the hauling of dirt from Wynn Roth's pond (attachment 03-08-12).
